Theses and Dissertations submitted to the UNIST library are deposited in many libraries and made available to the public electronically for preserving and sharing research results.

Therefore, **all authors of thesis/dissertation are required to make decisions on the access to their thesis/dissertation and agree to the thesis/dissertation usage conditions.**

Please refer to the following information and submit a signed ‘**Thesis/Dissertation Agreement**’ to the library.

## ※ UNIST Thesis/Dissertation Policy

- UNIST library encourages graduate students to **open and release their thesis/dissertation** to promote and share their research results.
- If **the thesis/dissertation is not available to release immediately** for some reasons such as publishing journal articles or patents, etc., **the author can make it temporarily restricted from public by selecting a ‘Conditional Access’ option.**
- Please discuss your choice on the ‘Access of Thesis/Dissertation’ with your advisor before making decision.
