

#### Thesis preparation and submission guideline

Thesis/dissertations shall be classified into thesis/disserations for examination and those for submission. When preparing a thesis, this guidleine must be referred to, and the guided form must be complied with. Degree thesis in UNIST must be written in English. The entire process of thesis writing shall comply with the research ethics.

#### 1. Thesis defense procedure



#### 2. Eligibility for submission of thesis

- A. In order to submit a thesis for a master's degree, the following requirements shall be satisfied
  - 1) Should obtain credits for completion and the GPA should be B0(3.0) or higher.
  - 2) Students who have passed the foreign language test(Implemented in accordance with the guidelines presented by each department(school)/major)
  - 3) Students who were recommended by the thesis advisor and the head of the school (department) \*Students who got approved by 3 committee members will be deemed recommended by the school(department) head
- B. In order to submit a thesis for a doctoral degree, the following requirements shall be satisfied.
  - 1) Should obtain credits for completion and the GPA should be B0(3.0) or higher.
  - 2) Students who have passed both Qualification Exam and foreign language test (Official English Qualification Test)
  - 3) Students whose research proposal have been approved.
    - <Submission of Research Proposal>
    - (Students entered before 2018) should submit the proposal at least 1 year before graduation
    - -(Students entered in 2019 and onwards) should submit the proposal within 2 years of entrance
  - 4) Students who were recommended by the thesis advisor and the head of the school (department) \*Students who got approved by 5 committee members will be deemed recommended by the school(department) head

#### 3. Composition of thesis committee (Examiner)

A. There shall be three master's thesis examiners including the thesis advisor, and the advisor shall be the chairman.



- B. An outsider with a doctoral degree in a similar field may be appointed as one the thesis examiners.
- C. There shall be five doctoral thesis examiners including the thesis advisor, and the advisor shall be the chairman.
- D. Outsiders with a doctoral degree in a similar field or faculty members from other major must be appointed as one or more of the thesis examiners, and there shall be three or more UNIST faculty members.

#### 4. Thesis for Examination

- A. The thesis for examination shall be written in English. There are no applicable limits to the quantity.
- B. MS Word shall be the basic writing tool.
- C. The paper size shall be  $A4(210\text{mm}\times297\text{mm})$ .
- D. An abstract shall be written within 1,000 words
- E. The completed thesis shall be submitted to the relevant thesis/dissertation examining committee.

#### 5. Thesis for Submission

- A. The front cover of a thesis shall be bound in hardcover(black)
- B. The front cover shall be followed by a title page with the title of the thesis indicated;
- C. The paper size shall be A4 (210mm x 297mm) and the color of the paper shall be white; print in single-sided paper.
- D. Photos shall be printed in such a way as to maintain their original colors;
- E. The thesis shall be bound with the confirmation of thesis/dissertation approval included;
- F. The composition of the main text sahll comply with the following requirements(for MS Word);
- 1) Main Content: Font size 11pt; Line spacing 1.5 lines;
- 2) Footnotes: Font size 9pt;
- 3) Typeface: Times New Roman;
- 4) Font color: Black (annexes including numbers and figures may be printed in color)
- 5) Margins: Upper 3 cm, Lower 2.54 cm; Left 2.54 cm, Right 2.54 cm (based on MS Word)
- 6) Page numbers shall be centered at the bottom of each page.
- G. An electronic thesis/dissertation file shall be made in a single file containing all contents including the title paper, abstract and image files. Also, its content shall be identical to the thesis/dissertation in bould form.

#### 7. Check your department and major name

When writing thesis, it is necessary for all students to double check department(school) and major name. Please refer to page 7~8 for exact names. \*Please note you should write major name only if the name of the major is different from the department(school) name)

- 8. Submission of thesis bound in hardcover
- 3 copies of both master's and doctoral thesis bound in hardcover should submitted to the library.

#### 9. Suspension of Degree Conferment

Students who fail to submit a printed thesis by the deadline shall be suspended from degree conferment in the semester and considered as the prospective graduate of the next semester, despite the passing of the thesis examination. (Regulations on the Degree Conferment Article 34)

#### 10. Cancellation of Degree Conferment

If a degree is obatined by a false or fraudulent method, the President may cancel the degree conferment. (Regulations on the Degree Conferment Article 35)

#### 11. Information on the revision of the thesis

After the final submission of the thesis, it is impossible to revise the thesis of the student who has received the degree. Special attention should be paid to write thesis in complying with the research ethics.



#### [Definitions of Research Misconduct]

- 1. "Fabrication" means fraudulent creation, recording, or reporting of nonexistent raw data, research materials, or research findings.
- 2. "Falsification" means distortion of research content or findings by artificial manipulation of research materials, equipment, processes, etc. or arbitrary modification or deletion or raw data or research materials.
- 3. "Plagiarism" means the following appropriation of another person's original ideas or creations that are not common knowledge without giving appropriate credit as to make it appear to third parties that such ideas and creations are the author's own
- 4. "False indication of authorship" means when a person who has made a scientific or technological contribution to research content or findings is not credited as an author without reasonable grounds, or when a person who has not made a scientific or technological contribution is credited as an author on the grounds of acknowledgment or privilege.

#### 12. Notification of research ethics.

To observe research ethics, UNIST confirms following two things during thesis defence.

- 1) Pledge of Observance of Research Ethics for Degree thesis: A pledge is submitted to prevent fabrication, falsification, plagiarism, false indication of authorship during thesis writing.
- 2) Plagiarism Judgement: Students should use Turn-it-in program to diagnose thesis plagiarism and should submit the result to the thesis committee prior to the thesis defence. Students should also submit the final plagiarism judgement result to the school. If the result is more than 20%, students should additionally submit plagiarism judgement report.


- Q1) Which color should I print the title page? Gold or Silver?
- A1) Use Gold.
- Q2) When submitting the electronic version of the thesis, should I submit a file containing the signature of the thesis committee?
- A2) You don't need to submit on the electronic file. However, please be aware that in the hardcover thesis the signature must be included.
- Q3) I would like to submit plagiarism Judgment result. Can I submit the result operated before final version?
- A3) During the thesis defence, the plagiarism judgment result must be notified to the thesis examiners. Also, when submitting the result to the school, the final result of plagiarism shall be submitted. If the result of a plagiarism judgment is 20% and over, an additional plagiarism judgment form shall be submitted. (Even if your thesis includes your own thesis, you must also submit the form.)
- Q4) How can I get a signature when submitting a hard copy of my thesis?
- A4) Three copies can be made by scanning the signed form, or one copy for real signed one and two with copied one, but the signature and name must be identifiable.
- \*If the paper is not identifiable, such as being scanned several times and changed to dark page, it cannot be submitted.
- Signature can be replaced by stamp, but should get committee's approval.
- Please be noted if you use a signature or stamp without the approval of the thesis committee, you can be legally punished and the degree can be cancelled according to Regulations on the Degree Conferment.
